### **Call to Order:**

Virtual and physical meeting called to order at 7:02 pm on *March 29th* by President Ben Davoren via Zoom Video Communications and at Mary's Pizza, Novato.

### **Approval of Minutes:**

Motion to approve the February 2022 Board Reports and Meeting Minutes was made by Tom Short, seconded by Jim Robison and unanimously approved.

### President's Report (Ben Davoren)

- Worked with Rick Duste on mechanics of MSR and CalendarWiz site updates for events
- Chiseled away at the outstanding pieces of the Bylaws review
- Drove as lead for the group on the extremely well-attended Rancho Nicasio mid-week tour, 61 people attended
- Updated MSR sites for upcoming events for April (Tour to Union Hotel 4/9 and Flying Lizard Race Day 4/16)
- Obtained PCA insurance for our events through April
- Quick update on our ridewithgps.com Club account: we now have 81 members signed up so this appears to be a popular addition

#### Items for discussion:

- Speedwaiver as our preferred default versus paper versus a hybrid (issue is that speedwaiver links do allow for 'backdoor' entries onto MSR). Is there a reason to change the current hybrid model?
- The issue is that guests signing up using speedwaiver are missing out on their contact information, meal choices and if you paid your fees. There is going to be further discussion to develop a solution to better see guests and attendees contact and choices data in MSR
- Jeff Hall and company are setting up a meeting with MSR to solve these issues
- Nominating committee should be stood up to help with Board membership planning now that COVID restrictions are hopefully decreasing.
- Our Bylaws (final version pending) state:

The Executive Council, by unanimous vote, shall appoint a Nominating Committee consisting of an active Past President and two voting members of the REGION. The Past President will chair the committee...No member of the Nominating Committee may be elected to an office in the same year in which he or she serves on the Nominating Committee. The Nominating Committee is responsible for nominating a slate of officers to serve in the following term... the Nominating Committee shall recommend to the Executive Council at least one, preferably two, or more candidates for each elected Officer position.

#### **NEXT STEPS**

- Staff the Nomination Committee per the by-laws, start early on looking for EC replacements
- Nominating Committee starts processing all solicited candidates
- Run Ad for leadership positions and the committee processes and acts on candidates
- Ben to run an ad for nominating committee member and reach out to the past president to get one of them to chair the committee
- Board is very interested to understand why so many members attended the Wed am tour, maybe a survey to discover that question

### Vice President's Report (Rick Duste)

Midweek event proved to be popular.

• 59 cars (40 in Group 1, 19 in Group 2)

- 77 people Not all stayed for lunch. Approx. 13 indicated they would not be eating.
- Due to shortage of leads/sweeps, groups were large (3 groups)
- As Ben mentioned, Speedwaiver functionality enables people to enter even after the event closes. It also did not capture their run group choice as a result.
- Have begun searching for a 2022 holiday party location. Keeping with north/south rotation each year, searching south locations.
- Stood in for President Ben at Zone 7 Presidents meeting in Roseville on February 26th. Of interest:
  - o National membership up 6.6% for 2021, 145,000 members
  - o Zone 7 had a 4% increase in membership in 2021.
  - Valley clubs experiencing significant growth in 2021, folks moving from the Bay Area. Diablo up 7%, Shasta up 5%,
  - Concours judging clinic scheduled for May 1<sup>st</sup>
  - o Let's confirm so we can add to the calendar.
  - Chip gave presentation on Sim Racing
  - Money available to regions 30-60 days advance notice to apply
    - \$750 if in conjunction with a charity event
    - \$500 for multi-region competitive event
    - \$500 for new member social
  - 4000 "incidents" on tours/per year
  - o INCIDENTS: If major, call Ken Laborde immediately 24/7 at 504-460-5500
  - o Certificate of insurance should be "physically" at the event
  - Waiver must be maintained for 95 months, Separate minor for minors, "parant" must be present when waiver signed (in person only, not electronically)
  - New drone standards coming April 4th. Drone usage will have to be approved by National and authorization number issued. Some of the requirements will include:
    - Pilot must be licensed per FAA FAR 107
    - Signed contract with region
    - \$5MM insurance with PCA and Region as additional insured
    - Signs notifying attendees
    - Visual observer provided by Region
    - Only used on perimeter, may not overfly cars
    - Video must have published statement and authorization number embedded on video

- Addition of separate run Group 2 in future events?
- Should we offer option on all tours to sign up but opt out of eating/participating at destination [ie. just do the drive only]?

### **Autocross Director's Report (Drew Powers & Stacy O'Connell):**

- Redwood AX#1 is coming up on Sunday May 15th at Thunderhill. It will be part of a shared weekend with SVR, which is hosting Saturday. Saturday will be ZONE AX#3 and Sunday will be ZONE AX#4.
- Waiting on a response from Doug Gale about our possible July and November dates at Sonoma Raceway
- Stacy will open registration for the May event in early April

#### **Items for Discussion:**

- SCCA is still in talks with Sonoma Raceway about paving a new lot. Sonoma's focus is Lot 2. Everyone else's focus is Lot 13.
  - Lot 2 is a kind of awkward shape, but usable. Though not much larger than the paddock. Attendance would likely have to be capped at 50 due to space. We would not be able to charge a premium price for entry. \$50-\$75. If we assume the low side to try to drive attendance, that will give us a break-even point of \$2500 for a site rental.

- Lot 13 is much larger, and we could charge a premium price for it. \$75-\$100. We would not have to cap attendance and should target 100 cars. Figuring the \$100 entry fee, that gives us a break-even point of \$10k. Though that is a big target and may not be realistic at first, especially without opening it up to groups outside of PCA. I anticipate that if we can get Lot 13 paved, Sonoma will likely be looking for \$6k-\$8k per day.
- There was lot of discussion, and we are looking forward to next updates on Lots
   2 and 13 paving
- Blacklisting problem attendees
  - This was discussed with a lot of examples and what remedies were available, after the meeting Tom Short weighed on information, he got from PCA and other HR colleagues

- Participated as a judge in the 2022 PCA Website Contest; leveraged the opportunity to survey multiple regional sites to get some insight into some future changes that will streamline information conveyance and bring our site into more complete compliance with PCA standards in several key areas. I will be working on noted required improvements in Q2.
- Have the names of three Redwood members interested in taking over webmaster responsibilities; each has general knowledge required for basic site maintenance and their own expectations re: the time commitment required. None are a perfect match for the site in its current state (securely hosted with statically generated content from a containerized, isolated, on-demand WordPress instance). As such, I am setting aside some time this Spring to plan a migration back to PCA provided infrastructure (still WordPress, but on the PCA dime and under their administrative control) to reduce the technical requirements for the position prior to moving forward with any transitions.
