 - Q3. Does the \$6000 from national preclude the region from other money-making activities during the Treffen? (My bet is the answer is yes, but since Kurt noted that 15+ years ago we netted \$35K from region-based events prior to Treffen being instituted, I figure we should ask). As a follow up to that question, does National control the options for other Porsche events (in particular gimmick and/or TSD rallies) as well as non-driving events (like balloon rides in the Napa Valley)?
 - Q4. Why did the Bend Oregon Treffen close registration before it was full and what are the implications for this proposed Treffen in Redwood Region?

 Registration opened last week for our 2nd Thunderhill event of the year. As of Monday, we had 18 registrants. Reminder email for our AX and Sequoia's was sent this morning at 9 am.
